REGULAR MEMBERSHIP

Regular Membership is open to any business entity that has been in the security business for one (1) year and is licensed as an alarm systems contractor in the State of Tennessee. Annual dues are based on the number of full-time employees per location, per this schedule:

MULTI-BRANCH MEMBERSHIP

Multi-branch membership is open to any national company with several branches in Tennessee. TNSI annual dues for a multi-branch company are \$770 per branch.

ASSOCIATE MEMBERSHIP

Associate membership is open to any business which is engaged in manufacturing, distributing, supplying, monitoring, dealing in or selling products or services relating to or necessary to members of TNSI. Associate members do not have voting rights and may not serve as an officer of the association. However, two representatives of Associate Members serve on the Board of Directors and vote therein. Annual dues are \$570 per year.

PUBLIC SAFETY MEMBERSHIP

Public Safety membership is open to any governmental agency or office involved with public safety who has the capability and desire to contribute to the advancement of the Association's objectives and purposes Public Safety Members do not have voting rights and may not serve as an officer of the association. Annual dues are \$310 per year.

AFFILIATE MEMBERSHIP

Affiliate Membership is open to any company who has the desire to contribute to the advancement of the Association's objectives and purposes. Affiliate members do not have voting rights and may not serve as an officer of the association. Annual dues are as described above for regular membership.
